## NOMINATION FORM - Nominations due October 18, 2024

The 2024 Volunteer of the Year Awards presented by the Grande Prairie Regional Association of Volunteer Organizations (the Association) recognizes the 2024 Individual Volunteer of the Year and Corporate Volunteer of the Year living/operating in the Grande Prairie region for outstanding contributions to the community through their support and acts of volunteerism.

Nominations may be made by not-for-profit and voluntary organizations, community groups, education institutions, levels of government or individuals in order to acknowledge a company who deserves recognition for their efforts.

The Awards will be presented at the 2024 Volunteer Awards Ceremony, during the Annual International Volunteer Day Celebration Breakfast on December 5th, 2024. The Grande Prairie Regional Association of Volunteer Organizations will notify award winners prior to presentation.

### Nomination Guidelines

1. Any company that has provided volunteer hours and/or encouraged and supported volunteer efforts by their employees (by informal or formal policy) and/or other means of support (equipment, facilities.) that have made a significant impact during the last twelve months in the Grande Prairie area is eligible.
2. The contribution(s) for which the Business receives nomination for must have occurred through November 2023 – October 2024.
3. Nominations cannot be submitted without the permission of the Business.
4. If more than one nomination is submitted for the same Business, all the information received will be considered as one submission.
5. Nomination form must be completely filled out and submitted on or before nomination deadline.
6. By signing the nomination form, each nominator and Business: Agree to abide by the guidelines that govern the Volunteer of the Year Award; Consents to participating in the awards program and in the nomination process; Consents to having photographs taken for award-related publicity purposes; & Consents to the use of the winner's name, photograph & nomination material in any awards-related publicity carried out by the Association.
7. The decisions of the selection committee are final.
8. Nominations (including all supporting materials) become the property of the Association and will not be returned. The Association takes no responsibility for incomplete, inaccurate, lost or late nominations.
